

The immediate Past President shall be a member, ex officio of the Committee .(Adopted 05.10.09).
- 2. "Members may serve for not more than three successive years in any one office unless otherwise determined and recommended by the Management Committee to members for decision." President is one year however maybe extended in special circumstances.(5c of Constitution)

Therefore the following Officers (encompassing the above responsibilities) will be required from the Club Membership to manage the Clubs activities to become Committee members.

Liaison Officer Webmaster Membership Officer
